This time of year is a hotbed for hacking and fraud. It is highly recommended to be extra diligent with your personal information and online activities.

Considerations:

Update passwords on all financial accounts, banks and credit cards.

Add extra security with dual factor authentication (sometimes called

- 2-Step Verfication), having a code texted to you upon logging in. You
- can also add biometric logins with face ID scanning. Change passwords and add dual factor to any shopping websites you regularly use, such as Amazon and grocery sites.

Freezing Credit

If you are concerned your information has been compromised you must go to each of

the three credit reporting agencies to freeze your credit. You do not have to sign up for a paid subscription, just elect the free option.
